Hence in order to develop Garhshankar Town and its surroundings in an orderly manner and to prepare its master plan under "The Punjab Regional and Town Planning and Development Act, 1995", the Governor of Punjab is pleased to declare the Local Planning area of Garhshankar Town within the meaning of sub section (1) of section 56 of "The Punjab Regional and Town Planning and Development Act, 1995". The total area proposed for Local Planning Area of Garhshankar Town is 45471 Hectares (112313 Acres) including Garhshankar Town and adjoining 161 villages. LOCAL PLANNING AREA

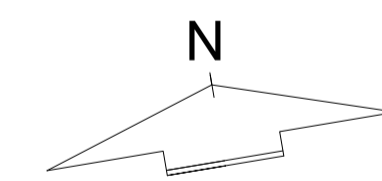
